#### Attorney's Report

Attorney Jarmer was present at the meeting in place of Attorney Hedinger.

Attorney Jarmer presented the first reading of the Annual Tax Levy Ordinance 1524-22 "An Ordinance Levying Assessing Taxes for the City of Auburn, Illinois for the year ending December 31, 22 (payable in 2023)". The only item that is being levied is a Public Park tax in the sum of \$46,000 that is levied and assessed on all properties in the city.

Office Manager Rathgeber sent Attorney Jarmer and Attorney Hedinger three Republic Service agreements in which the attorneys reviewed and provided comments on.

Mayor Berola and Alderman Garrett called Attorney Jarmer about how much land should be within a tract for an annexation. There isn't a clear-cut answer, the statue doesn't say a specific amount. There is case law that suggests that the longer the tract, the less you will find a strip annexation. Thirty feet seems to be the area that courts will find to still be contiguous.

The Hergenrother and Lincoln Militia complaints have been drafted, and will be filed once Attorney Hedinger returns from vacation.

#### **Department Heads**

Chief Campbell:

There was legislation passed that changed the SAFE-T Act so Chief Campbell is going through about 600 pages to make updates.

Rio Flesch started Monday, Dec. 5 and McDermand will graduate Friday, December 9th.

Chief Campbell received two packets on the buildings and will go through them once the Building and Grounds Committee has been established.

Superintendent Henson:

Christmas lights are up and working. There are timers on them, so if there are any calls about them, let TJ know.

North street project pipes and fittings came in, still short about 700 ft of pipe, but once a permit is received and weather permitting, they should be able to start first of the year.

Mayor Berola asked Superintendent Henson if the apprentices were still going to come dredge the pond and Superintendent Henson said yes, they absolutely want to be a part of that. Henson assumes it will be after the first of the year.

Alderman Garrett asked Superintendent Henson if there was a possibility to let the community know about the future projects like the North Street Project before it begins. Superintendent Henson said that we could do that.

Office Manager

Mayor Berola and Office Manager Rathgeber will be closing on the bank property on Thursday. A wire transfer is necessary for anything over \$50,000. This will go to the closing company.

They have gotten quotes from IlliniTek and Matrix Systems and will be presented at the December 19<sup>th</sup> meeting.

No offers yet on the Red Bud Park property. Mayor Berola said a letter needs to be mailed to Tony Dobson letting him know the property is going to be sold.
