Chief Campbell requested an executive session for personnel. He let the council know that McDermand scored a 100 on his first test. Chief Campbell also let the council know that he is working on a temporary liquor application and will need a changed ordinance for this.

Superintendent Henson:

Superintendent Henson provided the council with an update on the fiber being installed around town. The city employees are very busy There have been some complaints from homeowners around town for various reasons such as no notification of the work being done, a language barrier, trespassing, and tearing up homeowner's yards. There was a discussion about determining the right of way vs private property. If homeowners think that the companies are trespassing, the homeowners would need to call the police, but the exact property lines vs right of way would need to be located to proceed. A pattern would need to be documented to get an injunction.

The owner of 514 N. 5th Street were in attendance to discuss their property that has been declared a nuisance. The property was first declared a nuisance on September 2, 2021. Fines of \$800 have been accrued. The owner was notified that if the property was not cleaned up fines would be accrued at \$100 per day per the city's ordinance.

There was a discussion about a house on Kennedy that is in the process of building a 6-foot privacy fence in front of the house. This is a violation and is now on record as of the date of the meeting, September 19, 2022.

There was also discussion about the new structure being built on Jackson St. The structure is different from what was originally proposed, but there is a building permit on file so they are not in violation of anything at this point.
